AND

**NOW IT IS HERE BY AGREED** as follows:

- (a) The Company hereby grants to the Owner, who accepts, the right to berth the above mentioned Vessel at Mgarr (Gozo) Yachting Centre, under such terms and conditions as are specified in the '**Marina Rules and Regulations**', entitled '**Annex I – Marina Rules and Regulations**' a copy of which may be found on the marina website, [www.gozomarina.net](http://www.gozomarina.net) .
- (b) The Owner hereby declares and confirms that he is aware of, and agrees to abide by, the provisions of the abovementioned '**Marina Rules and Regulations**' also found on the marina website, [www.gozomarina.net](http://www.gozomarina.net) .
